# The RURAL Heart & Lung Study Kentucky Core Bulletin

With less than a year until the Mobile Exam Unit (MEU) is projected to arrive in Kentucky, the RURAL Team wanted to share information regarding the differences between a regular check-up at the doctor's office and the results given to participants from their baseline exam on the MEU. Participants will receive their results to share with their healthcare provider.

## Regular MD Exam vs. **Baseline Exam on MEU**





#### Regular MD Exam

#### **Purpose**

To improve health on an individual level by screening for diseases, assessing risk of future medical problems, encouraging a healthy lifestyle, etc.

#### Content

To provide tests that will maintain/improve wellbeing, and enhance knowledge of personal health

#### Results

To give recommendations for next steps that will better quality of life on an individual level

#### Value

To prevent adverse health outcomes for individuals

#### **Baseline Exam on MEU**

To increase understanding of health concerns in rural communities, with a focus on heart and lung health

To provide tests that help guide future programs for the improvement of health in rural areas, including tests related to heart, lung, and blood vessel health

To utilize study findings for addressing critical gaps in the knowledge of heart and lung disorders in rural counties in the southeastern U.S.

To identify risk factors for heart and lung diseases and to uncover solutions by examining differences between higher and lower risk rural counties



### Kentucky Activities

This Fall, the RURAL KY Team has been ramping up our community engagement efforts! Caleb Williams attended Back-to-School Bashes at Hazard Independent (Perry County), Jackson Independent (Breathitt County), and multiple Perry County schools in early August. On August 8th, Dr. Stephanie Boone and Stephie Abraham presented at a Boyle County Fiscal Court meeting to introduce the RURAL study to the magistrates and to discuss plans to prepare for the MEU's arrival in Kentucky in 2024. On August 25th and 26th, Stephie and Scotland promoted the study at the Garrard County Rural Heritage Tobacco Festival. They introduced the study to about 70 people and were able to connect with other community stakeholders at the festival.

In the month of September, Caleb attended the Black Gold Festival in Perry County, allowing the RURAL Study to reach hundreds of individuals in the communities within a brief period. Stephie and Scotland then presented at a Perryville City Council meeting to provide a brief overview of the RURAL Study and answer any questions regarding eligibility criteria and timeline for the MEU's arrival.

Our Team visited Boyle County during the first weekend of October to attend the Perryville Commemoration Festival. Later that month, they attended the Paint Lick Village Fest in Garrard County and set up a booth at the Boyle County Fiscal Court Health Fair. The Team then travelled to support Dr. Boone at the TEDxDanville event about the value of time spent on community engagement in epidemiology and population health studies. The edited video will be released later this year. Community Advisory Board (CAB) meetings were held in both counties, for which meeting minutes are available: Perry/Breathitt & Boyle/Garrard.






## A Word from Scotland Stewart:

#### Where Are We Now?

The MEU has officially moved to Panola County, Mississippi! As of October 2023, over 1,900 participants from Alabama and Mississippi have now completed their baseline exams. The MEU will move through Assumption and Franklin Parishes of Louisiana in Spring 2024 before heading to Kentucky in the Fall.

### Recruiting CAB Members

Through our in-person community engagement efforts, we have recruited a total of 6 Community Advisory Board (CAB) members (2 from Garrard, 2 from Boyle, and 2 from Breathitt counties). Yet, we are still searching for 4 CAB members from Garrard, 5 from Perry, and 5 from Breathitt counties.
